Expectations & Attendance Contract

To support your success, we ask that students engage in their coursework on a regular basis. We understand that life can get busy, and progress may slow down at times.

If a student goes three months or more without any course progress, the student's enrollment will be closed so that space and teacher support can be offered to others who are currently working in their courses. This is not a penalty, and there are no restrictions or wait times if you wish to continue later.

If you decide you would like to return and continue upgrading after being removed, you are welcome to reapply at any time. Simply submit a new application, and your course access will be reactivated within 3–4 business days after it is submitted.

As part of supporting student learning, attendance and engagement will be reviewed twice each school year, in January and June.
